**Seokwoo LEE** is Professor of International Law, Inha University Law School, Korea (2003- ), where he is also working as Director of Inha Int'l Ocean Law Centre. He is Vice Dean (Planning and Cooperation) (2024- ) and was Vice Dean for External Affairs (2009; 2012-2014).

He has conducted research at a number of institutions including the University of Tokyo, Harvard University, Georgetown University, Oxford University, Durham University, and George Washington University, and has taught at Xiamen University, China (2009), University of Hawai'i at Mānoa, USA (2013), and Zhejiang University, China (2013).

He was Chairman of the Foundation for the Development of International Law in Asia (DILA) (2012-2015; Acting Chairman, 2016-2017) and now serving as Chairman of the Development of International Law in Asia-Korea (DILA-KOREA) which is the academic institution which is responsible for the administration of DILA along with the *Asian Yearbook of International Law* (Asian YbIL) and Asia Pacific Ocean Law Institutions Alliance (APOLIA).

He is President of the Korean Branch of the International Law Association (ILA-KOREA) (2024-2025). The main publication of the Korean Branch is the *Korean Yearbook of International Law*.

He is Co-Chair of International Law Association (ILA) Study Group, *Asian State Practice of Domestic Implementation of International Law* (ASP-DIIL) (2018-2023) and a member of ILA Committee on *International Law and Sea Level Rise* (2016-).

He is a member of the Advisory Board for the Sustaining Coastal and Marine Zones of the University of Wollongong (UOW) Global Challenges Program in Australia, Deputy Director and a member of the Board Directors of the Jon Van Dyke Institute of International Law and Justice, William S. Richardson School of Law (WSRSL), University of Hawai'i at Mānoa, USA, and an Adjunct Research Professor of the National Institute for South China Sea Studies (NISCSS), Hainan, China.

He served Vice President of the Korean Society of International Law (2019) (Director of International Relations (2010-2011), Executive Board Member (2010- )) and served as Chairman of Research Committee, SLOC (Sea Lanes of Communication) Study Group-Korea (2010-2013).

His representative recent governmental and societal activities in Korea include Republic of Korea Navy, Development Advisory Committee (Law of the Sea Division); The Ministry of Foreign Affairs, Advisory Board for Dokdo Policy; Korea Coast Guard, Committee on the International Law of the Sea; Northeast Asian History Foundation, Dokdo Research Institute, Advisory Board for Dokdo Policy; and Province of Gyeongsangbuk-Do, Legal Advisor to the Dokdo Safeguard Team.

He is General Editor of Brill's *Encyclopedia of Public International Law in Asia* (EPILA) [2018- ]. Launching in 2020, the EPILA offers the first comprehensive examination of Asian approaches to international law and it will provide expert review and analysis of state practice from the past 30 years for about 16 different Asian countries. Offered online and in print as three geographically-organized volumes – Northeast Asia, Southeast Asia, and Central and South Asia – this reference work provides 16 state volumes involving 286 contributors who drafted 1,078 headings encompassing over 2,500 pages and over a million words. <https://brill.com/view/db/epil>

He is Co-Editor-in-Chief of *Asia-Pacific Journal of Ocean Law and Policy* (APJOLP) and *Asian Yearbook of International Law* (AsianYbIL), Editor-in-Chief of *Korean Journal of International and Comparative Law* (KJICL), Co-Series Editor of the book series entitled *Maritime Cooperation in East Asia* (MCEA), and Associate Editor of *Brill Research Perspectives in the Law of the Sea*, all published by Brill.

He is also an editorial board member of the *Australian Journal of Maritime and Ocean Affairs* (Taylor and Francis), *Pacific Focus* (Wiley), *International Journal of Marine and Coastal Law* (IJMCL)(Brill) and *Central Asian Yearbook of International and Comparative Law* (Springer).

He has extensive experience in organizing more than 80 major international conferences, including the *Annual LOSI International Conference on the Law of the Sea and Ocean Policy* with Law of the Sea Institute, UC Berkeley, *Annual DILA International Conference*, and *Annual APOLIA International Conference*.
